CONTEST QSLING - JIM N3JT

There are four parts to a DX contest: preparation including antenna pruning, rig tweaking, and computer checkout; the contest weekend itself; log preparation and dispatch; and QSLs. For the most part, the first three of these are accomplished in a relatively compressed period of as short as a few days in toto. The last — QSLs — takes a year or more because many of the cards arrive by the bureaus, a process taking in some cases more than a year each way. Can anyone actually remember any contact represented by the card received via the bureau?

Some contest operators and QSL managers have made it a practice to not return QSLs if the requesting station has gotten the call wrong. Particularly in contest environments, with QRM, QRN, stations claiming frequencies within 200 Hz of you, battles overturf, all the normal contest that we all persevere, there is an increased chance of copying a callsign wrong. What responsibility does the station receiving the QSL card have to respond to the request? Has there really been a legitimate contact if the callsign was incorrect? Could the receiving station confirm the contact if he or she wants, introducing the correct callsign and confirming the contact from his own log entry? Is there some room for leniency, recognizing the possibility the the other station actually copied the call correctly but erred in writing the card or transferring from sloppy contest logs to neater submission logs?

If the QSLing station appears in the log, why not respond with a QSL? After all, as a practical matter, if the manager had sent cards independent of receiving them he would have dispatched one anyhow! Moreover, how many times does the rare DX station err in sending his or her callsign? Can we know for sure that the callsign on the card was not correctly copied?

I think the balance in this sort of gray area seems to favor sending the QSL in response to a card that is accurate enough to have arrived at its intended destination. I think most QSL managers handle matters in this fashion and I am inclined to think Amateur Radio is better off for it. Any comments?

MISCELLANEOUS

Don't forget about the Fowlfest on Saturday the 4th of August at the K3ZO QTH. This will be the only local summer meeting, so if you usually get your two meeting per year in during the summer you will need to attend the Fowlfest and at least one meeting during the year. This year we will hold a meeting at the Gaithersburg hamfest, as well.


PVRC Charter member Cedric Van Pelt NØFFZ (now /9) was the top out of state scorer in the VA State QSO Party. Congratulations, Van.


